

Report of the Stated Clerk

Dear members of the Presbytery,

Grace and peace to you in the name of our Lord Jesus Christ!

We extend our sincere thanks and appreciation to Nacoochee Presbyterian Church for being such willing and gracious hosts for this meeting!

As required by Church Discipline, I have the duty to inform you that a congregation within the presbytery requested a reference to the Presbytery Judicial Commission in a disciplinary matter related to two ruling elder members of the same congregation. The PJC voted to accept the request for a reference and the presbytery has assumed jurisdiction over the matter. The investigation process is ongoing. Further updates will be provided at future meetings of the Presbytery, pursuant to D-7.0501.

The 2024 Session Minute reviews have been completed for the following congregations: First Athens, Belle Terrace, Christ, Covenant (Augusta), Christ, Dahlonega, Eatonton, Hartwell, Jefferson, Madison, and Sardis. If your session minutes have not been reviewed, please make arrangements with me to do so as soon as possible. I have included a copy of the Session Review Checklist on the next page. If there is anything at all that I can do to support you or the ministry of your congregation, please do not hesitate to be in touch with me!

POLICY REGARDING TIME LIMIT FOR PERSONS SPEAKING (Debate) AT PRESBYTERY MEETINGS

(Approved by Presbytery October 23, 2007) (Note: Presbytery can set aside such a rule when it deems necessary.)

When speaking at a Presbytery meeting:

- Individuals are limited to speaking once and for no more than three minutes during discussion of a matter.
- A bell may be used to signal when the speaker is near and at the end of his/her time.
- Moderator alternates between "pro" and "con".
- No one may speak more than once until every person who wishes to speak has had an opportunity to do so.
- Presbytery may set a maximum time for debating an issue.

Transitional General Presbyter's Report October 2025

Over the past six months I have attempted to engage with as many of our congregations as possible, preaching from time to time, meeting with pastors and sessions, participating in umpteen committee meetings (both in person and on Zoom), and fielding questions on an almost daily basis that often boil down to some version of "so what's the presbytery going to do to help us?"

Well, a lot of what "the presbytery" does goes on behind the scenes. The presbytery strives to ensure that all our congregations have sound pastoral leadership. There are high expectations for both character and competence, which is why it can sometimes be difficult to find qualified candidates. The presbytery promotes healthy relationships between pastors and sessions, and between congregations and the larger church. Presbytery occasionally steps in during times of difficulty, not ignoring problems but seeking to uphold the peace, unity, and purity of congregational life. The presbytery also works to provide opportunities for learning and service beyond the local congregation, such as the recent leadership events, and the ongoing disaster recovery project in Augusta. It should also be noted that the presbytery does not seek to enforce uniformity among our churches but rather uphold unity amidst our great diversity.

We should remember that "the presbytery" is much more than the four part-time staff members, and includes ruling elders and teaching elders from all our churches who generously give of their time, energy, and wisdom to carry out our common purposes. There are significant differences across our presbytery in the amount of resources, both human and material, that are available to sustain congregational life. In this season of change, it is therefore incumbent on all of us to be asking, "what can I do, and how can I help?" These are exciting times, and we know that the Lord is already at work in all our communities; our task is to discover what God is up to, and invite others to join us in the revealing of the kingdom that is to come, and that is already here through Jesus Christ.

Church Property Commission Report October 2025

In October of 2005, Northeast Georgia Presbytery approved the merger between the Westminster Presbyterian Church in Waynesboro, GA, and the John I Blackburn Memorial Church, also in Waynesboro. The Westminster church became the successor organization and the John I Blackburn property was subsequently closed. A recent offer for the John I. Blackburn property was received and approved by the Session of the Westminster Church. Proceeds from the sale will greatly enhance the mission and ministry of the Westminster church and Session requested approval from the Church Property Commission.

After reviewing the request the Church Property Commission approved the sale of the John I. Blackburn property as requested by the Session of the Westminster church.

Report of the Coordinating Team October 2025 Marc Galvin, Chair

The Coordinating Team met by Zoom on July 15 and on September 30. It also conducted an email vote to approve the September 20 Leadership Training at Oconee, another email vote to recommend a new Presbytery Treasurer to complete an unexpired term, and a third email vote to approve members for the Presbytery Transition Team.

Actions:

- 1. Approved the expenditure of up to \$4500 from the Connectional Events fund as a budget for the leadership event.
- 2. The revised Personnel Policy manual was approved as presented.
- 3. Dates for 2026 Presbytery Meetings were proposed and approved: February 28, May 19, August 22 for Leadership Event, and October 20. Sites are to be determined.
- 4. Approved the allocation of \$2,680, to match an amount from the Board of Pensions for financial assistance to a minister member of the presbytery. The Treasurer was granted the discretion to determine the source of funds.
- 5. Andy Cooke was approved to coordinate reservations for the Colladay Cottage in 2025 and 2026.
- 6. Will Norman was approved to serve a second three-year term on BFIT.
- 7. Approved the donation of \$5000 to Presbyterian Disaster Assistance for needs after Texas floods; \$2500 from Connectional Events Fund and \$2500 from the Justice and Peacemaking Fund.
- 8. By email vote, approved the Leadership Event at Oconee on September 20.
- 9. By email vote, approved that Ed Rees, Transitional General Presbyter, complete the term of Bob Prim as Presbytery Treasurer through December 31, 2026. Bob Prim is stepping away on October 31, 2025.
- 10. There was a request that BFIT be ready to present an alternative per capita plan at the October Presbytery meeting.
- 11. By email vote, approved a slate of names, listed below, to serve on the Presbytery Transition Team.
 - Rev. Steven Barnes; Pastor, Oconee; Chair, COM
 - Nancy Miller, Elder; Milledgeville; Chair, PW
 - Elaine Weigert, Elder; Cleveland; Chair, Congregational Connections
 - Rev. Teresa Franklin; Member at Large; Member, COM
 - Esther Moore, Elder; Westminster
 - Rev. Andy Cooke, Co-Pastor, Covenant (Augusta)
- 12. Approved an additional \$1000 in travel allowance for the Stated Clerk.
- 13. Approved a motion giving the Congregational Connections Committee authority over the Connectional Events Fund to fund their ministry.

Announcements:

- 1. Dates for 2026 Presbytery Meetings were proposed and approved: February 28, May 19, August 22 for Leadership Event, and October 20. Sites are to be determined.
- 2. Personnel Action Team announced that a new evaluation instrument will be utilized in performance reviews of Presbytery staff.

Recommendations:

- 1. Recommend that Ed Rees be elected as Treasurer to complete the term left vacant by Bob Prim.
- 2. Coordinating Team recommends that Presbytery approve establishing an endowment fund that would be used to fund the administrative work of the presbytery and ministries of member congregations from the remainder of the Trinity Fund and the Georgia Domestic Missionary Society Fund. Coordinating Team recommends to Presbytery a proposal (addendum #2) to establish and manage the endowment fund.
- 3. Recommend for Presbytery approval: "In the event of extraordinary circumstances in the coming fiscal year that require emergency expenditures by the Committee on Ministry, Nominating/Representation Committee, Permanent Judicial Commission, Property Commission, or Sexual Misconduct Pastoral Response Committee, the presbytery authorizes the Coordinating Team to spend up to \$5,000 from Undesignated Reserves, which shall be reported at the subsequent presbytery meeting. In the event that the Committee on Preparation for Ministry adds inquirers or candidates which necessitate additional expenditures, then they are permitted to exceed their budget accordingly."
- 4. Recommend to Presbytery an increase in the Presbytery's portion of per capita for 2026 that would allow for the majority of the Operating Budget to be funded through per capita: 2026: General Assembly--\$11.26; Synod of South Atlantic--\$2.00; NEGA Presbytery--\$48.11 for a total of \$61.37.
- 5. Recommend the 2026 Proposed Operating Budget to the Presbytery for approval at the October Presbytery meeting.

Subject: Ministry Update, Construction Completion, and Fall Campaign Status

Gratitude and Capital Project Completion

The Table Athens, Inc. extends its deepest gratitude to the Northeast Georgia Presbytery for the generous construction grant supporting the renovation of our Student Center restrooms. We are pleased to confirm that **all construction was fully completed this month**, and final payments have been cleared. This timeline was a bit later than planned, but still allowed us to utilize the renovated space for our 85th Anniversary Homecoming Dinner.

Ministry Growth and Success

Our **85th Anniversary Homecoming Dinner** was a wonderful and successful evening, serving as the official kickoff for our fall campaign. A highlight of the night included testimonials from three different students who shared their unique stories of finding a home for their faith, hope, and love at The Table.

We are excited to report that student participation in the ministry has increased by **nearly 40%** again this year, resulting in growing numbers at weekly dinners, worship, and Table Groups.

Supporting Ministry Scale and Growth

While this significant growth is of course exciting, we already feel the corresponding increase in the direct costs of ministry—we are providing more meals, buying more chairs and small group materials, and funding more scholarship requests for retreats and events.

To this end, The Table's fall fundraising campaign is off to a great start, thanks to the generosity shown at Homecoming. However, to sustain this 40% rise in engagement and keep up with the demands of an expanding ministry, we need to raise **an additional \$15,000** this fall. Report to Northeast Georgia Presbytery From the Manual of Operations Revision Task Force

Our team has been given the task to review the policies of Northeast Georgia Presbytery, as well as our Operations Manual, and make recommendations to the Presbytery for updates, deletions, or any other revisions that seem appropriate at this stage in the life of our Presbytery. This is work that must be done with care and with wisdom and discernment. Our goal is to have a document that will be accurate, clear, and easily understood so that it will be useful as a source of information for those who serve in this presbytery.

Our team has had two very productive meetings. We are currently working on the part of the Manual of Operations that addresses commissions, committees, and teams of the presbytery. When this section is finished, it will have more indepth information on the purpose of the commissions, committees, and teams in the overall work of the presbytery. It is our hope that, when finished, the document will contain the information needed for individuals who are serving on the commissions, committees and teams. We also realize that the document will only be beneficial if it is used.

Once finished with the first section, we will begin to work on the policies of the presbytery section. Since there is a separate Personnel Policies Manual, that information will not be repeated in this policy section.

Our goal is to have a document ready for a first reading at the February 2026 meeting with a second reading and vote at the May 2026 meeting.

Professional expense reimbursements should be made through an accountable reimbursement plan and should include-

- expenses necessary for the performance of the job
- professional subscriptions and books
- mileage for use of a personal automobile at the current Internal Revenue Service standard mileage rate for business travel.

Additional Information

- The Committee on Ministry conducts an Annual Salary Standards Review to ensure all installed pastors' compensation packages meet or exceed that year's minimum salary standards (covenant pastors' salaries are reviewed upon contract renewal). Reporting forms are emailed to appropriate clerks of session each January, to be completed by March 31.
- The Board of Pensions provides a guide to structuring ministers' terms of call, *Living by the Gospel*, as well as a dues calculator on its website, www.pensions.org.

Northeast Georgia Presbytery has adopted a Sabbatical Leave Policy, which states that pastors, associate pastors, and certified educators who have completed 6 years of consecutive credited service in the same call are eligible for 3 months of fully paid leave. Please contact your Committee on Ministry liaison for more information.

Committee on Ministry Recommendations

- The Committee on Ministry recommends that the base minimum salary be increased by 1% for each year the minister has been ordained.
- The General Assembly of the PC(USA) approved a revision of G-2.0804 which provides for a minimum of 12 weeks paid Family Medical Leave for all called and installed Ministers of Word and Sacrament. The Committee on Ministry encourages church sessions with contract pastors to prayerfully discern and make generous provision for their own family medical leave policies.
- The Committee on Ministry strongly recommends that both churches and clergy take advantage of the resources offered by The Board of Pensions and its website (www.pensions.org). These resources include information about benefits selection and administration, tax questions, changes to healthcare, retirement planning, and much more.

¹ Updated 8/12/2025 by a 2.7% increase, based on Bureau of Labor Statistics, Consumer Price Index.

² The Committee on Ministry recommends that pastors living in a manse receive compensation for the equity that they forego by not owning their own residence.

⁴ The rationale for \$1,000 being the recommended amount for continuing education is so that an adequate amount of financial support is provided for the "2 weeks including 2 Sundays" mandated for Study Leave on page 1. Unused continuing education funds may be carried forward for up to three years.

FINANCIAL REPORTS FOR NORTHEAST GEORGIA PRESBYTERY

WHAT ARE THE COMPONENTS OF A FINANCIAL REPORT?

- The Budget Report gives an overview of the whole budget, with a single line item listed for each of Presbytery's Committees and Commissions. It includes all of the activities that are supported by Shared Mission and Per Capita contributed by the member churches, and by investment and other sources of income for presbytery's budget.
- 2. The **Committee Reports** (including the Coordinating Team and Staff Salaries Reports) provide a breakdown for some of the line items in the Budget Report, and give greater program, mission, salary, and operational expense details.
- 3. The **Balance Sheet** gives an accounting of the presbytery's assets, liabilities, and equity, which includes temporarily restricted net assets. It also provides information on the presbytery's cash assets and limitations on how those assets may be spent.
- 4. The **Church Giving Report** lists each church with all shared mission, special benevolence, and per capita apportionment monies remitted to Presbytery.

WHEN AND TO WHOM ARE REPORTS MADE?

Financial summary reports (Budget Report and Balance Sheet) are included in the Handbook for each Stated Meeting of Presbytery. Other financial reports are included in the Handbook if they pertain to the business being discussed at the presbytery meeting. Any financial reports included in the Handbook are also included in the printed minutes of Presbytery.

Full and complete financial reports (1 - 4 listed above) are available upon request from the presbytery office, and are printed in the Annual Minute Book for Northeast Georgia Presbytery.

WHAT ABOUT AN AUDIT?

Northeast Georgia Presbytery, since it was organized in 1988, has had its financial records reviewed annually by certified public accountants. In October 2019, presbytery revised its policy to direct that a financial review be conducted annually by a certified public accountant.

Each CPA report is reviewed by the Coordinating Team and is printed in the Presbytery's permanent Annual Minute Book. That Annual Minute Book is also reviewed by the Synod of South Atlantic. A copy of any financial review is available in Presbytery's Office.

EXPLANATION OF RESTRICTED FUNDS

Northeast Georgia Presbytery is charged with managing a number of fund accounts separate from and in addition to its own budget. An accounting of these funds is shown on the Balance Sheet under "Equity". The following are descriptions of those accounts.

UNDESIGNATED RESERVES

This reserve fund was created at the inception of Northeast Georgia Presbytery with uncommitted monies from three former Presbyteries: Georgia, Augusta-Macon, and Athens. The **Income source** is Shared Mission budgeted contributions left unused at the end of any year. **Expenditures**: undesignated reserves may be used by decision of Presbytery: (1) to make up any deficit in Presbytery's annual budget; (2) to care for Presbytery expenses during "lean" months when those expenses are greater than contributions from churches; and (3) for any other purpose which Presbytery may decide. By Presbytery policy, the balance in undesignated reserves shall not fall below \$20,000.

1001 NEW WORSHIPING COMMUNITIES FUND

In October 2023 the Presbytery Moderator appointed the 1001 New Worshiping Communities Task Force to explore ways the presbytery could encourage and support new worshiping communities within its bounds. Presbytery approved designating proceeds from the sale of the Carnesville and Hopewell church properties, as well as interest earned on the Trinity Fund toward 1001 New Worshiping Communities. **Income sources** are interest earned on the Trinity Fund until December 2025. **Expenditures** are any grants authorized by the Coordinating Team.

ASSISTANCE FUND

At its February 28, 2015, stated meeting presbytery approved establishing this fund by combining the monies from the Assistance to Ministers, Pastoral Care, Sabbatical, Aid to Candidates, and Staff Development funds. The Assistance Superfund is under the oversight and authority of the Coordinating Team. **Income sources** are any benevolences received for this purpose. **Expenditures** are any grants authorized by the Coordinating Team. Grant applications may be found on the presbytery website.

BETH DUNCAN FUND

This fund was created from earnings of the Beth Duncan **Endowment** Fund (see below), and is under the oversight and authority of a Beth Duncan Fund Committee, which is made up of appropriate members of Presbyterian Women of the Presbytery. **Income sources** for the Beth Duncan Fund are earnings from the Beth Duncan Endowment Fund, a prorated portion of interest earned by the various cash accounts of the presbytery, and offerings taken at PW gatherings.

Expenditures are any authorized expenses of the PW moderator and expenses related to the PW Annual Gathering, Fall Retreat, and Churchwide Gathering.

BIPOC (Black, Indigenous, People of Color) FUND

The fund was created at the adoption of the Presbytery's Anti-Racism Policy in May 2025. Per the policy, the fund was created by transferring 10% of the balance of the Georgia Domestic Missionary Society Fund and is under the oversight and authority of the Committee on Representation (COR). **Income sources** are 10% of all church property sales. **Expenditures** are grants authorized by COR for: scholarships for seminary education for BIPOC candidates for ministry; funding to enhance the ministry and witness of BIPOC congregations; financial assistance to BIPOC congregations with emergency needs; supporting efforts of racial healing and identity formation beyond race within any church in the presbytery, or for the presbytery as a whole, and; to fulfill any other purposes deemed appropriate by the COR in consultation with the Coordinating Team.

CLERGY CARE FUND

The Clergy Care Committee forms cohorts designed to provide support and fellowship to minister members of the presbytery. Ministers make a three-year commitment to their cohort, and the participants, their sponsoring organizations, and the Clergy Care Committee partner monetarily to help cover the costs associated with the cohorts, including a retreat experience in the final year. **Income sources** are annual participant fees, sponsoring organization fees, and amounts from the Clergy Care Committee's annual operating budget. **Expenditures** are costs to conduct the cohort groups, such as facilitator honorariums, monthly meeting meals, and expenses for the third year retreat experience.

COLLADAY COTTAGE FUND

In May 2025, the Presbytery approved a partnership with William Black Lodge in Montreat, NC, in which NEGA would gain an ownership interest in the small cottage on the property. A 25-year lease agreement was signed with NEGA paying WBL an initial \$150,000 for use on upgrades, maintenance, landscaping, and access to the cottage, to be named the Frank Colladay Cottage, in exchange for use of the Cottage for 13 weeks/91 nights per year to provide rest, retreat, and renewal in Montreat for individuals who are currently employed and serving in ministry (pastors, commissioned lay pastors, youth & children's ministry directors, music directors, and Christian educators) within the Northeast Georgia Presbytery. Following the Initial Payment, NEGA would pay WBL \$1.00 per year for years 1-15 of the lease, and \$5,000.00 per year for years 16-25 of the lease. The Retreat Endowment Fund, held at Presbyterian Foundation on behalf of NEGA, was liquidated to make available funds to satisfy the lease agreement. **Expenditures** are annual payments to William Black Lodge per the terms of the lease agreement.

CONNECTIONAL EVENTS FUND

At its February 28, 2015, stated meeting presbytery approved establishing this fund by combining the monies from the Church Professionals Retreat, Overnight Presbytery Meeting, Retreat Program, and Retreat Scholarship funds. At its inception the fund was under the oversight and authority of the Coordinating Team, who on September 30, 2025 granted oversight and authority to the Congregational Connections Committee. **Income sources** are any benevolences received for this purpose and any registration fees received for related events. **Expenditures** are any grants authorized by the Coordinating Team. Grant applications may be found on the presbytery website.

EMERGENCY RELIEF FUND

This fund was created in February 2025 with a grant received from PDA and other donation to support the Augusta community in their recovery from the aftermath of Hurricane Helene in Fall 2024. The fund is under the oversight and authority of the Budget/Finance Initiative Team. **Income sources** are a \$7,500 grant from PDA and any benevolences received for this purpose. **Expenditures** are grants of up to \$5,000 (depending on the fund balance) to address natural and other disasters that severely impede a member congregation's or other affiliated worshiping community's ability to function.

GEORGIA DOMESTIC MISSIONARY SOCIETY FUND

This "society" was developed early in the history of Presbyterianism in Georgia. Its purpose was to make possible the development of churches, and to assist smaller churches to grow in size and mission. In 1985, the Society was effectively disbanded, and all of its funds were turned over to the Treasurer of former Athens Presbytery. As successor to former Athens Presbytery, Northeast Georgia Presbytery is custodian of the fund. The current policy of Northeast Georgia Presbytery is that member congregations with up to 150 members may apply to borrow from the Fund at a simple interest rate of 0.5% "to improve accessibility, to repair storm and disaster damage, to replace or provide equipment necessary to perform worship and education functions, or to improve facilities in ways that will directly enhance program outreach ministries." Principal and interest must be paid on a regular monthly basis, and complete repayment must be made within ten (10) years. A session may apply for a loan through the Coordinating Team, and loans must be approved by Presbytery.

At its Stated Meeting on October 24, 2015, presbytery approved Campus Ministry at UGA be granted the provision (pre- approved by presbytery without need to request or consult presbytery for use of funds) to access up to \$10,000 in emergency funds for building repairs/maintenance from the Georgia Domestic Missionary Society to be repaid on the same terms as other organizations of presbytery with access to these funds.

Income sources are: (1) interest and principal paid by churches with loans; (2) income from investments made with the Presbyterian Foundation (see below) by the former Comer and Danielsville Churches at their dissolutions; and (3) at least 25% of funds received from church facility and property sales. **Expenditures** are any loans approved by Presbytery.

JUSTICE AND PEACEMAKING

The **income source** for this account is the Presbytery portion of the Peace & Global Witness Offering contributed by local congregations. **Expenditures** are under the authority of the Coordinating Team.

PROPERTY PROTECTION AND DEFENSE

This fund was established in 2017 in response to the lawsuit related to the Alps Road property. **Income sources** are any benevolences received for this purpose. **Expenditures** are any payments authorized by the Coordinating Team. This fund is under the oversight and authority of the Coordinating Team.

SPIRITUAL DIRECTION FUND

Upon the death of Stated Clerk Emeritus Rev. Joe Berry, the Presbytery received a gift from the Lois and Lucy Lampkin Foundation in his memory. The Presbytery approved a recommendation by Coordinating Team to create the Spiritual Direction Fund using this gift for grants related to spiritual direction. **Expenditures** are under the authority of the Coordinating Team.

TRINITY CHURCH FUND

Trinity Presbyterian Church was dissolved June 25, 2023, and the building and property were sold on October 25, 2023. At its August 2024 Stated Meeting, Presbytery approved the following appropriation of the fund: 1) \$1 million be designated in support of the proposal from The Table Athens for student housing development, and 2) the balance (\$37,971.53), plus earnings from the current Certificate of Deposit and additional 13-month investments, be designated in support of 1001 New Worshipping Communities. At the May 2025 Stated Meeting, The Table Athens reported the student housing project was not feasible and withdrew their claim to the \$1 million gift. Presbytery approved a \$250,00 grant to The Table Athens to renovate their restrooms.

ASSETS HELD ON BEHALF OF NORTHEAST GEORGIA PRESBYTERY:

The Presbyterian Church (USA) Foundation holds assets for the benefit of Northeast Georgia Presbytery, Inc. These funds are permanently restricted and contain provisions for the income generated by the principal to be distributed to Northeast Georgia Presbytery, Inc. as outlined in the fund documentation on file.

BETH DUNCAN ENDOWMENT FUND

This endowment fund was created following the death in 1958 of Anna Margaret Auld Duncan of Elberton in memory of her daughter, Beth Duncan. Her will stipulated that income from the Endowment Fund is to be used "in the furtherance of the work of the Church carried on by the Women's Organizations of the church." Earnings from the endowment are credited to the Beth Duncan Fund for use by Presbyterian Women.

HELEN GERR CARTLEDGE AND CLEYN MARTIN CARTLEDGE MEMORIAL FUND

In 1990, Northeast Georgia Presbytery was notified by the Presbyterian Foundation of the death of Cleyn Martin Cartledge and the establishment of this endowment fund. Mr. Cartledge's will stipulated that ½ of all net income be distributed to "the proper authorities of the Westview Presbyterian Church, located on the Atlanta Highway in Clarke County, or any successor, as long as they are affiliated with the Presbyterian Church (U.S.A.), said income to be used for the general program of said church." West View Presbyterian Church had been dissolved March 26, 1989, and in accordance with Church policy, Northeast Georgia Presbytery became the successor organization and income beneficiary. At its May 20, 2000, Stated Meeting, the presbytery named Oconee Presbyterian Church as successor to the West View Presbyterian Church, however, the presbytery remains the legal successor. Presbytery instructed Presbyterian Foundation to remit earnings directly to Oconee Presbyterian Church.

COMER PRESBYTERIAN CHURCH FUND OF ATHENS PRESBYTERY

Comer Presbyterian Church was dissolved April 15, 1969, and the remaining cash assets were used to establish this endowment fund. Donor stipulations are that "all income from this fund be sent to the Central Treasurer of Athens Presbytery and used in the work of the Presbytery in areas now under the supervision of the committee on the church (church extension) or its successor. This committee shall have full discretion in the use of this income." Earnings from the endowment are credited to the Georgia Domestic Missionary Society Fund.

DANIELSVILLE PRESBYTERIAN CHURCH FUND

Danielsville Presbyterian Church was dissolved October 12, 1976, and the remaining cash assets were used to establish this endowment fund. Donor stipulations are that "all income from this fund be sent to the Central Treasurer of Athens Presbytery to be used in the work of Athens Presbytery or its successor in the area now under the supervision of the Committee on the Church and Its Work or its successor, and that this committee have full discretion in the use of this income." Earnings from the endowment are credited to the Georgia Domestic Missionary Society Fund.

LEXINGTON PRESBYTERIAN CHURCH CEMETERY ENDOWMENT FUND

This fund was established by Lexington Presbyterian Church with the restriction that "proceeds from this endowment fund shall be paid to Lexington Presbyterian Church on a perpetual basis and shall be used for the upkeep, maintenance, and repair of the church's historic cemetery and, if and when additional funds become available, for the preservation of the historic sanctuary." The church was dissolved May 3, 2015, and Northeast Georgia Presbytery became the successor organization and income beneficiary. On May 22, 2017, the church

building and property, including the cemetery, were sold to the City of Lexington with the stipulation that the earnings from the endowment fund be forwarded to the City for perpetual care of the cemetery.

RICHARD AND GUS STAPLER LOWE MEMORIAL FUND

At the time of the establishment of this fund, the income beneficiary was Washington Presbyterian Church and there are no restrictions on the use of the earnings. On September 27, 2016, the church was dismissed to ECO: A Covenant Order of Evangelical Presbyterians, and Northeast Georgia Presbytery became the successor organization and income beneficiary. Initially, quarterly earnings from the endowment were used to pay legal fees for defense in the lawsuit related to the Alps Road property. At its January 29, 2019 meeting, Coordinating Team approved future earnings to be included in the General Operating Budget as investment income.

Christian stewardship is awareness that everything we have is a gift from God. We are absolute owners of nothing; rather, we are stewards of all we receive, and we must use such resources responsibly in our life-long work of service in the Reign of God. Stewardship heightens an awareness of responsibilities in matters of material concern no less than in spiritual endeavors

MISSION OF THE ENDOWMENT FUND

The Endowment Fund is created and exists solely for charitable purposes for the promotion and development of Christian worship, outreach, and nurture within the Presbytery of Northeast Georgia.

ESTABLISHMENT OF ENDOWMENT FUND

We, the commissioners of the Northeast Georgia Presbytery, move to establish The Northeast Georgia Presbytery Endowment Fund, (hereinafter referred to as "The Endowment Fund"), as a permanent fund of the Northeast Georgia Presbytery, hereinafter referred to as "The Presbytery." The Endowment will be seeded with existing money from the Georgia Domestic Missionary Fund, the remainder of the Trinity Fund, and...?

The Endowment Fund shall be subject to the laws of the State of Georgia, the Articles of Incorporation of The Presbytery, Discipline of the Presbyterian Church (USA), actions of the Stated Meetings of the Presbytery, and the following covenants:

- I. The Endowment Fund is created and exists solely for the support of the Presbytery and the worshipping communities that comprise the Presbytery. The Endowment's principal objectives are to support the administrative work of The Presbytery and to offer grants to local worshipping communities.
- II. The Endowment Fund shall receive and hold all designated gifts made to The Endowment Fund, from sources such as bequests, gift annuities, insurance policies, trusts, or other planned or deferred arrangements, as well as specific cash gifts, or from the sale of Church property.
- III. The principal of The Endowment Fund shall not be expended, except as provided in Article IXc. The Budget and Finance Team of the Presbytery (hereinafter referred to as B/FIT) shall establish the value of the principal of the Endowment Fund on December 31 of each year.
- IV. Not withstanding anything to the contrary, each year a distribution will be made available to the Presbytery and worship communities from The Endowment Fund. This distribution will be calculated as up to 5% of the average balance of the total fund for the previous twelve quarters (three years). The first funds will be available for distribution three years after the Endowment Fund is funded. The distributions will be based on applications made to B/FIT and approved by the Coordinating Team. Up to 25% of the distribution may go to the administration of the Presbytery.
- V. The Endowment Fund shall exist under the authority of The Coordinating Team based upon recommendations of B/FIT.
- VI. B/FIT is empowered to act as follows:
- a. Be the fiscal agents for The Endowment Fund
- b. Accept and acknowledge un-restricted, un-designated gifts to The Endowment Fund or other gifts as specified in paragraph c. below.
- c. Review any gifts with restrictions or designations that are proposed to be placed in The Endowment Fund with regard to their compliance with the corporate purpose and the exempt

status of the Presbytery. The recommendations of B/FIT to accept or decline a gift for inclusion in The Endowment Fund shall be reported to the Coordinating Team. The Coordinating Team will accept or decline any gifts to The Endowment Fund.

- d. Invest the monies of The Endowment Fund in such a way as to achieve a reasonable and adequate growth of the fund while not incurring significant risk to the principal of the fund. Capital growth of Endowment Fund assets may be considered part of the principal of The Endowment Fund.
- e. Maintain a record of all gifts to The Endowment Fund: the value, the donor, the date and the type of each gift, as well as any formal expression by the donor(s) of the use to which the gift might be put.
- f. Maintain a complete accounting of all investments, including investment vehicles used from time to time, the principal of the fund, capital gains, earned income and dividends, distributions and expenses.
- g. Report to the Coordinating Team, when requested, the current state of The Endowment Fund. A report should be made to the Presbytery, not less than annually, and should include a statement of any distributions made from The Endowment Fund, and of the amount of money currently available for distribution.
- h. Promote and advertise The Endowment Fund frequently and consistently throughout The Presbytery and its membership. Costs for this activity may be charged to The Endowment Fund and paid out of current income.
- VII. B/FIT shall recommend the projects/purposes for which funds are distributed, and these recommendations shall be ratified by the Coordinating Team.

VIII. Any portion of the annual, distributable funds not distributed in any given year will be retained in The Endowment Fund for expenditure in future years.

- IX. None of the monies of The Endowment Fund will be used to support the following:
- a. Propaganda or other attempts to influence legislation.
- b. Political campaigns on behalf of any candidate for public office.
- c. The programs of local churches which are regularly funded by pledges and contributions of members, except in cases of extreme emergency determined by B/FIT. Extreme emergencies are ultimately determined by B/FIT but will always be considered in consultation with the Coordinating Team.
- X. B/FIT shall be responsible for an annual review of The Endowment Fund. The findings and recommendations of said review shall be presented annually to the Coordinating Team and The Presbytery.
- XI. The covenants of The Endowment Fund may be amended by a three/fourths (3/4) favorable vote of a Presbytery meeting, except that the Coordinating Team may make an amendment if needed to comply with any IRS requirement.
