Dear Friends,

On behalf of the entire congregation of Oconee Presbyterian Church, I want to say how happy we are to host the 121st meeting of the Northeast Georgia Presbytery and to welcome our sisters and brothers throughout the presbytery to our church campus on Tuesday, May 21, 2024.

The members of OPC are a loving family of faith that truly believes its mission is to:

Invite in all people to constantly discover the love and Grace of Jesus Christ.

Build up one another in the fellowship of the Holy Spirit, encouraging everyone to discern & use their gifts.

In fact, we **invite you to help us keep out "Little Free Pantry" stocked** this summer, when schools are out for summer break, and food insecurity rises due to students not being able to rely upon the breakfast and lunch meals they can get when schools are in session. *Here's the ask*—when you come to the meeting, we encourage you to bring a variety of nonperishable food items (nothing home cooked):

- Proteins—tuna, canned chicken, etc.
- Soups—all kinds, especially anything with protein (chicken, beef, pork, beef stew, hearty soups, etc.)
- Canned veggies and fruit
- Boxed breakfast items—cereal, oatmeal, fruit & nut bars
- Even pastas, flour, instant potatoes, dry milk, etc.

The church's address is 2601 Hog Mountain Road, Watkinsville, GA 30677, and it is located just down the road from Oconee County High School and the Oconee County Civic Center. There is only one driveway in and out of the property, with parking spaces along both sides and in the back of the sole church building. OPC members will be available to welcome you and direct you to available parking as needed.

Registration will be set up in our narthex, which is accessible through all three building entrances. Childcare will be available in our nursery.

The public Wi-Fi network is OPC_Guest and the password is opcguest (all one word, all lowercase).

We are grateful for the opportunity to open our doors and welcome everyone to our church. Prayers abound for safe travels to our campus on Tuesday, May 21.

Northeast Georgia Presbytery
April 22, 2024

Members Present: Mari Turner, Hilary Shuford, Brenda Boonstra, Dea Devereaux, Ron Gilreath, Whitney Booth-Lockard. Also attending: Stated Clerk Ed Rees and Jacob Douylliez.

Mari opened the meeting with prayer.

A quorum was present.

The Manual of Operations setting forth the responsibilities and authority of the Church Property Commission and its history of practice in Northeast Georgia Presbytery was fully discussed. The Commission unanimously approved moving forward in taking actions as a commission, rather than as a committee, and reporting same to the next Stated Meeting of the Presbytery.

First Presbyterian Church, Cornelia application to Presbyterian Investment and Loan Program was reviewed. Brenda Boonstra, elder from Cornelia, reported that the congregation had voted to approve. She further reported on the congregation's plan for the use of the funds and the repayment plan. Hilary and Brenda further described the congregation's involvement and activities in the community, the strength of pastoral leadership, and the use of "every square foot" of the property for the mission and ministry of Christ.

Brenda excused herself from the meeting.

The motion to endorse the application and to guarantee the loan, acting with full authority as the Church Property Commission, was made by Ron Gilreath and seconded by Whitney Booth-Lockard.

The motion was unanimously passed by the 5 voting members present. The Stated Clerk will report this action to the Presbytery at its next Stated Meeting on May 21, 2024.

There being no further business, the meeting adjourned after Hilary offered the closing prayer.

Stated Clerk's Report
May 21, 2024

In our Reformed understanding of church polity, we are governed by a combination of Teaching Elders and Ruling Elders. Neither of these “outrank” the other; rather, they have separate tasks but are colleagues together in leading the church. With this understanding, it is our practice to ensure that an equal number of Teaching Elders and Ruling Elders are participants in our Presbytery meetings. Each church is allocated a certain number of Ruling Elder commissioners, based on membership; this allocation is updated each year based on membership data submitted by the churches, and is designated as the Parity Report.

Motion: To adopt the Parity Report for 2023-2024 as presented.

A reminder to Clerks of Session: we are approaching the season for reviewing Session minutes; be on the lookout for instructions for the examination and certification of your records.

As you know, at our February meeting I reported to you that I had received formal complaints against two minister members of Presbytery, and that in accordance with the rules for church discipline, two Investigating Committees had been formed to look into these matters. At this point both committees are still engaged in this difficult but necessary work, and I will keep you informed going forward.

Rules for debate:

POLICY REGARDING TIME LIMIT FOR PERSONS SPEAKING (Debate) AT PRESBYTERY MEETINGS

(Approved by Presbytery October 23, 2007)

(Note: Presbytery can set aside such a rule when it deems necessary.)

When speaking at a Presbytery meeting:

1. Individuals are limited to speaking once and for no more than three minutes during discussion of a matter.
2. A bell may be used to signal when the speaker is near and at the end of his/her time.
3. Moderator alternates between “pro” and “con”.
4. No one may speak more than once until every person who wishes to speak has had a opportunity to do so.
5. Presbytery may set a maximum time for debating an issue.

Proposed Allocation of Ruling Elder Commissioners

August, 2024 – May, 2025

Voting Commissioners at meetings of Northeast Georgia Presbytery include all Minister Members plus:

1. Ruling Elders serving the Presbytery in official capacities (Chairs of Ministry Teams or Commissions, Presbytery Officers, and Commissioned Ruling Elders to a Particular Service), and
2. Ruling Elders elected by their sessions to serve as Commissioners.

The latest statistics available from the PC(USA) show a total of **123 Minister Members** in Northeast Georgia as of December 31, 2023. Therefore, in order to achieve parity between Minister Members and Ruling Elder Commissioners, the total number of Ruling Elder Commissioners must be at least **123**. There are currently 7 Ruling Elders serving in the categories identified in (1) above. Therefore the number of **Ruling Elder Commissioners representing congregations must be at least 116**.

The chart on the following page shows the number of Ruling Elder Commissioners (REC) to be elected by each congregation, based on the following criteria:

1. Every congregation is entitled to at least **one REC** (shown as the “Base”).
2. In keeping with the policies and historic practices of Northeast Georgia Presbytery, each predominantly racial/ethnic congregation is allocated **one additional REC**.
3. To assure proportional representation of all members, additional RECs are allocated to larger congregations in numbers based on the congregation’s membership. The chart displays congregations in order of size, with the largest receiving the most additional RECs:

500 members or more:	5 additional RECs
250-499 members:	4
200-249 members:	3
100-199 members:	2
45 – 99 members:	1

This brings the total number of Ruling Elder Commissioners (including those serving in official capacities) to **123**.

If this report is approved by the Presbytery, the chart on the following page will be in effect through the Spring (May) meeting in 2025, when an updated proposal will be presented.

**Report of the Coordinating Team
for the February 2024 Presbytery Meeting**
Mari Turner, Chair

The Coordinating Team (CT) met on April 16, 2024 at Oconee Presbyterian Church.

For Information:

1. A letter was received from the Backyard Ministry thanking the Presbytery for the support and funding that has been given.
2. Two Teaching Elders are needed for service on the Nominating Committee for the class of 2026. It is anticipated that this vacancy will be filled at the July CT meeting.

Actions:

1. Approved the minutes of the January 23, 2024 meeting.
2. Heard a report from the Colladay Cottage Task Force and approved action plan to engage in conversation with The William Black Lodge.
3. Received and approved a recommendation from the Personnel Action Team regarding steps to address the presbytery office needs when Anita Green transitions to part-time employment and approved a recommendation to begin the process of engaging an independent contractor to manage the presbytery data for 1 to 2 hours a week at up to \$30.00 per hour.
4. Received and approved a recommendation from the Personnel Action Team regarding contracting with Synod of the Sun Communication Services to take over media and communications roles that Anita will no longer do when she becomes a part-time employee.
5. Appointed a Communications Action Team with the following members: General Presbyter Hilary Shuford, Stated Clerk Ed Rees, Committee on Ministry Chair Jacob Douylliez, Coordinating Team Chair Mari Turner, and Congregational Connections Chair Burnetta Armour, to work with Synod of the Sun Communication Services.
7. Received and approved recommendations from BFIT:
 - a. The Funds Grant Application form be updated to state that grants are for "non-degree educational" purposes.
 - b. Accepted into record the financial review from Seymour & Perry LLC of the 2023 financial records.
 - c. Paying expenses to ship legal records related to the Alps Road lawsuit (approximately fourteen boxes to the Presbyterian Historical Society in Philadelphia from the Property Protection and Defense Fund.
 - d. Affirmed the action of reinvesting the funds held at Presbyterian Investment and Loan Program, which are maturing on April 30, in a 13-month investment certificate at a special promotional rate of 4.5% interest.
8. Authorized the Stated Clerk and the Moderator to finalize the docket for the May meeting.
9. Designated the May meeting offering to go to the Justice and Peacemaking Fund.

Recommendations for Presbytery vote:

1. Providing assistance to the Stated Clerk by hiring Jacob Douylliez for 10 hours per month at \$500.00 per month for a term of 7 months.
2. Amending the 2024 Operating Budget to provide up to \$1,000 in professional/travel reimbursement for the Treasurer, with reimbursement being retroactive to January 1, to include the funds to pay for data entry assistance, assistance for the Stated Clerk, and adjust the Business Administrator's salary to reflect part-time employment.
3. Continuing to endorse The Table and renewing of Presbytery's 2004 resolution related to the tax-exempt status of The Table Athens, Inc at the University of Georgia as an affiliated ministry of Northeast Georgia Presbytery from October 26, 2004:
 - a. That Northeast Georgia Presbytery acknowledges The Table Athens, Inc at the University of Georgia as an affiliated ministry of Northeast Georgia Presbytery;
 - b. That Northeast Georgia Presbytery approves the programmatic purposes of The Table Athens, Inc at the University of Georgia; and

- c. That Northeast Georgia Presbytery, through its Coordinating Team exercises oversight responsibility for The Table Athens, Inc at the University of Georgia and its programs and financial integrity.
- 4. That First Presbyterian Church, Gainesville be the host for the August Presbytery meeting.

Presbytery Report from The Table Athens, Inc.

The Table Athens (formerly Presbyterian Campus Ministry), has just completed its most consistent and highly attended ministry year since at least 2018.

Average weekly worship attendance for the year was 36 students, with a total of nearly 80 individual students who participated in person at some point this year.

Each week we are in email contact with over 200 students, both undergraduate and graduate, and began hosting campus wide events to broaden our exposure, as well as to promote an inclusive approach to Christian faith.

The decision to rebrand and change the organizational name to The Table Athens, Inc. was the next logical step in our ecumenical expansion project.

To clear up any remaining confusion, The Table continues to represent the Presbyterian Church (U.S.A), and the Reformed Tradition of Christian faith. Since 2020, the ministry has also represented the United Church of Christ. Since our May 6th board meeting earlier this month, The Table also represents the Christian Church (Disciples of Christ). And finally, by way of informal relationships with two Athens area congregations, the Table also represents the Cooperative Baptist Fellowship. Each of these denominations includes, but is not limited to the Reformed tradition, and each of them has agreed to our partnership requirements of

1. affirming the full participation of all people in all aspects of Christian life and ministry regardless of race, ability, gender identity, or sexual orientation
2. supporting the practice of an open communion table;
3. supporting the staff and board in establishing and maintaining communications with congregations, student recruitment, and identifying denominational grant opportunities;
4. making a meaningful financial contribution to the ministry.

Finally, as our ecumenical relationships expand, it becomes less practical to require regional judicatories (such as the NEGA Presbytery) to play an active role in the governance of the organization, but rather a reporting relationship seems more appropriate. To that end, in our most recent bylaws update, the responsibility of this presbytery to 'approve new board members' has been amended so that The Table is responsible for reporting board updates to each regional judicatory each year, but to soliciting formal approval. It is our hope and intent that this change will lighten the burden of the NEGA nominations committee as well as The Table Staff, without weakening in any way the relationship between The Table and NEGA.

2. What has ceased to be relevant?

In summarizing the action plan associated with the current vision through the lens of the above two questions of relevance, the collaborative is working with four verbs to frame our work ahead: **Care, Create, Cultivate, Connect**

To help fill out the discernment process, small group discussions will be facilitated by V26 Members at the May Presbytery meeting, focused on the following scripture and discussion questions:

Ephesians 4:1-6, 11-13, 15-16

OPENING QUESTIONS

1. What makes us unique (as individual congregations, within our particular contexts)?
2. Where do you encounter God's Joy, Grace, and Love in your community?
3. What breaks God's heart in your community?
4. What do we need to hold onto?
5. What do we need to let go of?
6. Who or what is missing at the table as we ask these questions?

Additional Ruling Elders are to be appointed to the Task Force.

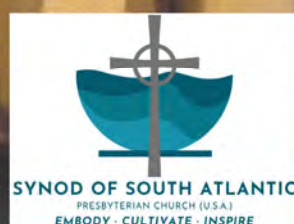
