Dear Sisters and Brothers in Christ,

Grace and peace to you in the name of our Lord and Savior Jesus Christ. What a joy it is to welcome you to First Presbyterian Church Cornelia and Habersham County. On behalf of the session and congregation of FPC AND members of The Backyard Ministry, we are thrilled to host this 119th gathering of the Northeast Georgia Presbytery.

First Presbyterian Church, a proud Matthew 25 congregation, has long been a staple in Cornelia since its founding in 1905 by the Rev. Henry F. Hoyt, who also founded the Mt. Airy Presbyterian Church in 1906. Today, the "Mt. Airy Chapel" houses The Backyard Ministry for Sunday morning worship and is used by FPC throughout the year for special services, most notably at 11 PM on Christmas Eve. The original Cornelia Church was built in 1907 about a block away from our current location. Today's sanctuary was dedicated on April 8, 1951.

Outreach has always been a part of the fabric of FPC as we were the very first to broadcast worship services on the radio and have helped create many of our local ministries (like *Sharing and Caring* and *Habersham Christian Learning Center*) that continue to serve our community. We were among the first to begin welcoming refugees from Laos post-Vietnam War in 1979. The Laotian ministry today has taken a different shape from where it began 40 years ago into what is now known as The Backyard Ministry, a 1001 New Worshiping Community as designated by our denomination.

We believe strongly in the good stewardship of the resources God has given us in our buildings. Whether it's the chapel in Mt. Airy, the fellowship hall, or the Annex building, we continue to open our doors to others in need of a ministry partner. Today, we host English classes for Hispanic immigrants four times a week, AA/AIAnon groups twice a week, SAT prep classes, community choir practices, a community clothes closet, and a Hispanic Pentecostal congregation three times per week. We also allow the homeless to use our showers as needed throughout the week. There is always something going on at FPC!

Our meeting will take place intentionally around round tables in our fellowship hall. It is my prayer that the spirit of welcome and hospitality we work so hard for here at FPC will be shared at each table. I want to encourage you to take time during the meeting to get to know someone new. Take time to share your story and listen to the stories others. It is through these times of sharing we will find God in our midst.

When arriving at the meeting please park in "upper lot" above the main church building (behind an old bank building) or in the parking lot adjacent to the church in the shopping center, which houses the Post Office and Dollar General. Please reserve the "lower" lot for folks who might appreciate a little less walking distance. "469 North Main Street, Cornelia, GA" is a great way to find us using GPS. Parking attendants will be standing by to direct you as needed. Please enter the church through the main doors under the portico. Here you will register, find the restrooms, and be directed to Scoggins Hall where we will meet. The Wi-Fi network connection is *WIN\_500277* and password is *qsf878bsn7*. This meeting is an inperson meeting only, so we hope you will make the trip to the mountains to join us. Hopefully, the fall colors will be starting to really pop by the time we gather.

We look forward to seeing you in Cornelia and pray the Lord's blessings on us all as we prepare for our time together.

### Stated Clerk's Report October 2023

Many thanks to those Clerks of Session who have completed their Session minutes review and forwarded their checklists to me. If we can finish this task by year-end I would greatly appreciate it. In the coming year we are going to revert to our former practice of holding in-person review meetings in each of our Mission Communities to facilitate a more timely and thorough examination of Session minutes.

It is typical at this season of the year for congregations to hold officer elections and conduct training for those elected to serve as elders and deacons. There are training videos and discussion handouts available to facilitate the work of equipping those who are called into ordained service for their work. In reflecting on our policy for speaking at Presbytery meetings, please remember that Commissioners have both voice and vote, and are encouraged to exercise both. If you have questions, please raise your hand to be recognized, and come to a microphone, identify yourself and your church, and fire away. Our best work is done when we all participate fully in collegial discussion and debate, seeking the Lord's will for our Presbytery.

# POLICY REGARDING TIME LIMIT FOR PERSONS SPEAKING (Debate) AT PRESBYTERY MEETINGS

(Approved by Presbytery October 23, 2007) (Note: Presbytery can set aside such a rule when it deems necessary.)

When speaking at a Presbytery meeting:

1. Individuals are limited to speaking once and for no more than three minutes during discussion of a matter.

2. A bell may be used to signal when the speaker is near and at the end of his/her time.

3. Moderator alternates between "pro" and "con".

4. No one may speak more than once until every person who wishes to speak has had a opportunity to do so.

5. Presbytery may set a maximum time for debating an issue.



# Report of Rev. Hilary Shuford, General Presbyter

Northeast Georgia Presbytery (PCUSA) 119th Stated Meeting, October 24, 2023

In August my report stated that we are responsible both for the planting of seeds and the nourishing of seeds. I hope we can expand our communal understanding of what this means when we meet in person on Tuesday, October 24, in the mountains of Northeast Georgia. Being in person also will afford us an opportunity to meet new people and re-introduce ourselves to others we haven't seen for a while.

We will gather around tables in the fellowship hall of First Presbyterian Church in Cornelia. I pray that our meeting format will allow us to deepen our relationships and connections and allow us to engage in focused conversations throughout the meeting. The keynote address, with some Q & A, will feature the Rev. Dr. Lindsay Armstrong, Executive Director/CEO of the New Church Development Commission in Greater Atlanta Presbytery. Our co-host, Rev. Souvanh Touralack and The Backyard Ministry will provide a sumptuous feast of Thai/Lao food. There will be a basket for donations, and we are asking everyone to contribute \$15.00 for lunch (checks can be made payable to The Backyard Ministry).

Before I share some pastoral concerns, I want to invite every pastor in Northeast Georgia Presbytery to lunch on Friday, November 17, at Covenant Presbyterian Church in Athens. The Clergy Care Committee will be sending invitations with an RSVP. The purpose of our gathering is to share table fellowship and to engage in conversations with each other, with members of the Vision 2026 Collaborative, and with Clark Simmons, our representative to the Board of Pensions (who is also paying for lunch). We have not gathered together as pastors since the pandemic when we gathered by zoom to reaffirm our vows.

Join me in praying for Rev. Dr. Haruko Ward who is retiring on December 31 from her long service as Professor of Church History at Columbia Theological Seminary and for her husband Peter, a member of Greater Atlanta, who is recovering from a heart attack. And join me in praying for Candidate Courtney Pittman who will be examined for ordination, having been called to serve Madison Presbyterian Church, and for Rev. Corey Ingold who has been called to serve Monticello Presbyterian Church. Also join me in praying for the family and friends of Rev. Miriam Dunson who passed away peacefully October 11, 2023. Finally, please continue praying for the people of Ukraine and pray for the Jewish people and the Palestinians in Israel whose lives, peace, and security have been devastated in the massacre perpetrated by terrorists known as Hamas: pray for protection of all the innocent people, especially children, of Jewish people and Palestinians, and all who have been taken hostage. # **Committee on Ministry Recommendations**

- The Committee on Ministry recommends that the base minimum salary be increased by 1% for each year the minister has been ordained.
- The General Assembly of the PC(USA) approved a revision of G-2.0804 which provides for a minimum of 12 weeks paid Family Medical Leave for all called and installed Ministers of Word and Sacrament. The Committee on Ministry encourages church sessions with contract pastors to prayerfully discern and make generous provision for their own family medical leave policies.
- The Committee on Ministry strongly recommends that both churches and clergy take advantage of the resources offered by The Board of Pensions and its website (<u>www.pensions.org</u>). These resources include information about benefits selection and administration, tax questions, changes to healthcare, retirement planning, and much more.

# **Corey Ingold** Statement of Faith Journey

I have sometimes thought of my life as being like a river that is fed by many streams and creeks along the way of its course. That seems especially true when I think of my journey as a Christian believer and as a Minister of Word and Sacrament.

One stream was my culture and the influence of my parents. Born at Presbyterian Hospital in Charlotte and raised in Commonwealth Presbyterian Church there, it's easy for me to see that the church has been a part of my life from the very beginning. Experiences in Sunday School and children's choirs and all manner of church-related activities together comprise a stream that gave me nurture which was reinforced at home by committed Christian parents. My church family and family of origin all seemed to take seriously their promises made at my baptism to raise me up to know and love God and to pray with me and for me.

Another stream that fed the river of my life is a love of philosophy and historical theology first cultivated in the latter years of high school and in college at St. Andrews. There was a sense in which I felt a need to translate the faith of my childhood into language and thoughts compatible with what I discovered as I learned about the history of the Christian church and the development of the many ways God and Christ have been understood by theologians through the ages. It was more complex than I had ever imagined it to be as a child, but it also helped me to understand that God was calling me to a faith that engages the mind as well as the heart. This stream required me to go deeper with God and to see that God's kingdom has many textures and flavors.

The stream of the church and its influence began to exert its influence again when I was hired to work with the Christian Education ministry at Roswell Presbyterian near Atlanta back in 1988. That experience was an opportunity given me by God to get my feet wet doing quite a number of meaningful things in the church from working with youth groups and the Wednesday night program to ordering Sunday School materials and helping teach the confirmation class. It was during this time that the call of God to ministry really began to take shape in my life. Following some career counseling, I enrolled at Columbia Theological Seminary in Decatur and was ordained in 1992 following graduation in May of that year.

Another stream that continues to leave an indelible mark upon me spiritually is the call to ministry itself. My 31 years of parish ministry thus far have been filled with joys and sorrows and likely with successes and failures insofar as those things can ever be measured. Yet, one of the things that never fails to instill a sense of awe in me is the way God allows me to be with the people of God in so many important moments of life. The privileges of officiating a wedding or presiding over a memorial service or sharing in the sacraments are things I am called to do because of who I serve and seek to glorify in ministry. It is a calling pastors cannot live into without the help and mercy of God, but it is also an honor to be a caretaker of God's holy things in a role of church leadership.

There are many people who have taught me something important to know in pastoral work. There are experiences that have shaped me for better or for worse, but I can only trust God will use them to help me continue to try and claim my calling.

A final stream of influence is that of the recent conversations between me and members of the Monticello Presbyterian PNC and the process of discernment we have all been engaged in during recent weeks. Having sought the Spirit's counsel, it now seems evident to all concerned that God has extended a call for me to serve that congregation as its pastor.

Therefore, it is with great joy that my wife, Nancy and I have accepted the call to come and serve at Monticello Presbyterian Church. It's true to say that, like all congregations of God's people, the Monticello church is unique and comprised of people who are fearfully and wonderfully made as the Psalmist puts it. They surely have a unique witness to offer their community and the larger world. And yet, the church of Christ is always unified in him, the One who makes all things new. So, in this new time for Monticello Presbyterian and for my wife and for me, we trust that God will continue to provide for our needs. As always, it is a great privilege to serve the risen Lord in the church he established upon the firmest of foundations, the Gospel of his death and resurrection.

# **Corey Ingold**

### Statement of Faith

I believe that God created the world and made it good. A sacred order was established out of chaos. God is sovereign both in heaven and on earth. Humans were created with free will, but the stain of human sin has corrupted this freedom. Therefore, humanity stands in complete reliance upon God's grace and mercy for salvation to become a reality. Our freedom is conditioned by obedience to God.

God is triune, three persons of one substance. The Father, Son and Holy Spirit constitute this holy Trinity. These three persons are co-eternal, the Son begotten of the Father and the Holy Spirit proceeding from the Father and the Son.

God so loved the world that, in the fullness of divine self-revelation, God's Son was sent into the world. This sending was incarnational, not docetic. Jesus Christ was conceived of the Holy Spirit and born of the Virgin Mary to bring God's light into the world. Jesus Christ is unique insofar as he was both fully human and fully divine. Jesus lived on earth as an itinerant rabbi preaching a gospel of grace and deliverance. Jesus' death on a cross atoned for human sin as he took upon himself God's judgment like a sacrificial lamb. On the third day following his crucifixion, God raised Christ from the tomb that we might hope for eternal life in his risen name. I believe that salvation comes through faith alone and that faith is a gift to God's people by divine grace freely given. The appropriate response to such a gift is repentance and a turning away from sin. This begins the process of sanctification, a lifelong pilgrimage of spiritual development.

Following Christ's ascension into heaven, God sent the Holy Spirit to dwell within the emerging church. It has sustained and blessed the work of the church since that day of Pentecost. The Holy Spirit offers both comfort and counsel to all God's people.

God has chosen to be revealed to humanity in a variety of ways. The Word of God became flesh in the person of Jesus Christ, but the Word is also revealed in the scriptures. I believe the Bible to be the unique and authoritative witness to Jesus Christ for the church universal and God's word to me. Scripture teaches us that Christ commanded followers to observe the sacraments of Baptism and the Lord's Supper. These sacraments enact and seal what the Word proclaims and testify to the ongoing nature of God's grace and providence for the church. True Christian worship takes place when the Word is faithfully proclaimed, and the sacraments are rightly administered.

The church of Jesus Christ exists to glorify God and equip Christ's followers for the tasks of discipleship to which they are called. Because God ordained the church as Christ's body, it is critical to remember that Christ is the head of the church. Our denomination's Constitution, which is comprised of the Book of Order and the Book of Confessions, is itself subordinate to Christ as the scriptures give testimony to him. Yet, the confessional nature of our denomination points us to the ways God's people have attempted to discern the will of God in a variety of historical contexts.

The authority of elders and ministers within Presbyterian church government is biblically sound and specifically delineated in the Book of Order. Yet, these offices point only to differences in function among God's people. The Reformed understanding of the priesthood of all believers asserts that all persons have ministries to which they are called each according to the gifts and abilities God has bestowed upon them.

# **Courtney Pittman**

# Statement of Faith Journey

I was raised in what could easily be the set of "The Real Housewives of Alpharetta." In other words, my upbringing was extremely white, extremely privileged, and extremely out of touch with the real world. I grew up living in a country club with a Labrador retriever, a thoroughbred, a sister who was Homecoming Queen, a business executive for a father, and a mother who stayed at home so that she could cut the crusts off our sandwiches and taxi us around to our afterschool activities. I wanted for absolutely nothing during my childhood nor did anyone else in our bubble of wealth and privilege. In fact, I wasn't even aware housing projects existed until my freshman year at UGA when I noticed rundown identical buildings across the street from the dormitories. Admitting all of this now is incredibly cringeworthy, but I also think my ivory tower upbringing is important in my spiritual and religious journey. Recognizing my advantages and privileges based solely upon the color of my skin and the money in my parents' bank accounts was a sort of a Saul on the road to Damascus moment. It hit me like a ton of bricks, and I immediately felt the need to right the wrongs of my upbringing.

Now to be fair, I think my parents were doing what they felt was right. Both had grown up in homes that struggled financially, and, like all parents, they wanted better for their own children. One area where they, "totally failed," as my father has stated on multiple occasions, is providing my sister and I with a faith foundation. We didn't attend church and the only God I knew of was the one of hellfire and brimstone that my Southern Baptist grandparents preached about. Try telling a relatively rebellious and mouthy teenager that if she didn't read her Bible every night (as if I even had a Bible!) that she was going straight to hell. I can vividly remember my Nanaw and Papaw telling me that homosexuals were sinners and that women in no way belonged in the pulpit. They made God seem like a pretty terrible character. It was a major turnoff and it made me believe that religion was simply not for me. While I always believed that there was a higher power, I certainly didn't have a relationship with him or her and wasn't even sure how to find him or her in the phonebook. Mom and Dad never really pushed the issue and I for sure wasn't waking up early on a Sunday morning to put on a dress and tights.

So, while a number of factors led me in my search for faith, the reckoning of the rape I endured in college was pretty much the event that launched me forward. When it happened, I didn't deal with it. I didn't talk to anyone about it. It took almost 15 years before I actually sat down with a therapist to unpack the trauma. As it turns out, unresolved grief can make you do some crazy things. It was in that unpacking, however, that I recognized within me this stirring of something holy. For so long I had felt unworthy of a relationship with God, so I simply never pursued one. What I know now is that God was always pursuing me. I was (and am) just as worthy of a relationship with God as anyone else. And praise be for that because Imposter Syndrome can be all too real.

In the midst of all of this self-discovery and healing, my family and I joined a church. We quickly realized that it takes a village to raise a child and we knew we needed a faith foundation for our little family. My husband and I were baptized together (at 33 and 31 years old!) and my boys soon followed. Before long, I was writing devotionals and giving my testimony before the entire congregation. I was later ordained as an Elder and here I am about embark on a journey into congregational ministry. What a wild ride. The call of Christ comes when you least expect it and at the most inconvenient of times... in my case, the hot mess that was 2020. Nevertheless, I answered the call and have been riding the roller coaster of faith ever since.

While reading the Bible, the historical and socio-political context of the text should be considered as the world behind the text is essential to understanding the word. I believe that the Bible is not to be used as a weapon, but is inspired by the Holy Spirit and seeks to express the love and grace of God to all, regardless of race, religion, or sexuality.

I believe in the importance and significance of the sacraments. While we are God's beloved at birth, I believe that Baptism is an outward display of commitment to God and the Church. It is a visible sign of an invisible grace. Baptism signifies that the journey of faith is to be done together as a Beloved Community of believers who walk alongside each other. I believe that the baptismal waters are ordinary, yet holy, and represent a covenant between the baptized and the Redeemer. I believe that the Lord's Supper is a way to give thanks to God and to remember God's gift of grace through Jesus Christ. I believe that all are welcome to the Lord's Table and that, by the power of the Holy Spirit, Christ is present at the Table.

I believe that the Church is a movement. It is not four walls and a table. Instead, the Church is God's faithful action in the world that seeks to spread the perfect love of Christ to imperfect people. The Church is to be an inclusive community of different individuals from different backgrounds at different points in their faith journeys. The Church is about celebration - the celebration of the Triune God and the celebration of one another.

Thad is in his final year at Columbia Seminary and is moving toward candidacy. Courtney graduated from Columbia last May and has just received a call to be Pastor of Madison Presbyterian Church.

In 2024, we will continue to guide Kris and Thad in their discernment process and are expecting to enroll at least one new inquirer.

# Report to Coordinating Team from Budget/Finance Initiative Team October 3, 2023

Recommendations for Approval by Coordination Team:

- B/FIT recommends that Coordinating Team recommend to presbytery a 3.3% increase in presbytery per capita rate from \$9.10 in 2023 to \$9.40 in 2024.
- B/FIT recommends that Coordinating Team recommend to presbytery the attached 2024 budget of \$406,423 (attachment).
- B/FIT recommends that Coordinating Team recommend to presbytery the following resolution to accompany the budget.
   "In the event of extraordinary circumstances in the coming fiscal year that require emergency expenditures by the Committee on Ministry, Permanent Judicial Commission, Property Commission, or Sexual Misconduct Pastoral Response Committee, the presbytery authorizes the Coordinating Team to spend up to \$5,000 from Undesignated Reserves, which shall be reported at the subsequent presbytery meeting. In the event that the Committee on Preparation for Ministry adds inquirers or candidates which necessitate additional expenditures, then they are permitted to exceed their budget accordingly."

# Proposal for the Frank Colladay Cottage The Rev. Andy Cooke May 16, 2023

As board member of the William Black Lodge (WBL) in Montreat, NC and the treasurer of Northeast Georgia Presbytery (NEGP), I see an opportunity for these two organizations that I serve to mutually benefit from a partnership.

William Black Lodge is a three-story lodge with 25 guest rooms on North Carolina Terrace in Montreat, NC. Adjacent to the lodge, but fronting on West Virginia Terrace, WBL owns a small cottage that is lovely, but somewhat burdensome (for pictures, please visit <u>https://williamblacklodge.org/cottage.html</u>) It doesn't produce the level of income that the rest of the lodge produces, which makes it difficult to justify the expense of maintaining it. Ideas of mothballing it or selling it have been floated among the board, but others do not want to let go of it. This is an ongoing challenge for WBL.

At the same time, Northeast Georgia Presbytery has a potentially related challenge with an account at the Presbyterian Foundation called the *Retreat Endowment Fund*. This fund has its origins with a presbytery capital campaign in the early 1980s, which had the purchase of a retreat center as one of its stated goals. In the late 1990s, the presbytery invested these funds with the Presbyterian Foundation and the funds became restricted to the purchase of buildings or property for a retreat center. At the end of the first quarter of 2023, these funds totaled approximately \$168,000. This amount is probably not enough to ever purchase land or build a retreat center, let alone maintain it. As far as I could see, this money looked like it would never be able to be utilized and would remain with the Foundation in perpetuity.

WBL and NEGP both have challenges here that could be overcome by the other organization. WBL has a building that doesn't make economic sense to utilize, and NEGP has funds that are nearly impossible to utilize. A partnership between these organizations might allow us both to be better stewards of all that God has given us.

As a member of both organizations, it has occurred to me that it might make more sense for WBL to sell the cottage to NEGP for the full amount of the Retreat Endowment Fund, but for WBL to keep the land beneath it (a ground lease). WBL could maintain the property, including all capital expenditures, in exchange for the revenue generated from it. NEGP could have free access to the property for a set number of days each year (perhaps 30 days), which they could give to their clergy for retreats.

If this partnership were to happen, then it would be appropriate to rename this cottage the Frank Colladay Cottage since Frank was such a beloved presence in both NEGP and at Montreat. I believe that the members of NEGP would be grateful for the chance to remember Frank in this way and to be able to enjoy a retreat center named for him.

This would benefit WBL with an infusion of funds into this cottage and the publicity of their ministry among the members of a presbytery with which it does not have a historical or formal connection. It would also fit well with WBL's historical mission to provide a place of retreat and renewal for persons serving in professional and avocational ministries.

I spoke with a few leaders from both NEGP and WBL in late 2022, and I found enthusiastic responses from both. I contacted Robert Hay at the Presbyterian Foundation to ask if this might be feasible, and he said that it was, though it would require a special review by a committee at the Foundation. In February 2023, I officially brought it to the Board of Directors at WBL. At the May 2023 board meeting, the board voted to invite NEGP to make a proposal. I took responsibility for formally communicating this action to NEGP on behalf of WBL.

As a member of NEGP, I am glad that we have the opportunity to craft this proposal rather than receive it. I think that it would be wise to bring this to the attention of the Coordinating Team on July 25 and the Church Property Commission. If we decide that we would like to explore this further, then I think that it might also be wise to hire a real estate attorney in Buncombe County, NC to advise us along the way and to help us close what would be an unusual real estate transaction.

At the same time, I would respect members of NEGP who thought that this may not be the best use of the Retreat Endowment Fund. I acknowledge that I have a conflict of interest, and I may not be able to see the interests of one organization apart from the other. I am happy to put it into the hands of the leaders of Northeast Georgia Presbytery and to follow their lead as we attempt to be wise stewards of God's gifts.

# Bills and Overtures Committee

Report to Presbytery October 2023

The Session of First Presbyterian Church of Cleveland respectfully overtures the Northeast Georgia Presbytery to send the following overture to the 226th General Assembly of the Presbyterian Church (U.S.A.)

The Presbytery of Northeast Georgia respectfully overtures the 226th General Assembly (2024) to send to the presbyteries the following proposed amendment for their affirmative or negative votes.

#### Shall D-7.0302(e) be amended as follows:

### When Jurisdiction Ends [Upon Renunciation of Jurisdiction]

Jurisdiction in a **[The]** disciplinary process **[does not]** ends-when a church member or a minister of the Word and Sacrament against whom an allegation has been filed renounces the jurisdiction of the Presbyterian Church (U.S.A.) in accordance with G-2.0407 or G-2.0509. In this case, the clerk of session or stated clerk of the presbytery shall report to the council both the renunciation and the status of the matter at that time, including the name of the accused, the date and fact of renunciation during an investigation or trial, and the charges, if filed. If no charges have been filed, the report shall include the nature of the alleged offense. **[The** *judicial process shall then proceed, per Church Discipline. At the discretion of the person alleging harm, a pastoral inquiry may be made in lieu of or concurrent to a full investigation and disciplinary trial, in accordance with* G-3.0109b(6). The clerk of

#### RATIONALE

The text of this overture is similar to text that was approved by the 225th General Assembly (2022) and was subsequently ratified by a majority of presbyteries. This amendment was not included in Church Discipline, the replacement to the Rules of Discipline. The new Church Discipline emphasizes the right of the person making the accusation to pursue a pastoral inquiry in the event that a person who has been accused renounces jurisdiction. However, there are situations in which it would be wholly appropriate for the investigating body to conclude the full disciplinary process. This overture preserves the intent in the new Church Discipline to provide for pastoral sensitivity while giving those who have made an accusation the opportunity to continue seeking justice, correction, and restoration through the full judicial process, regardless of whether or not the person accused recognizes jurisdiction.

The Presbytery of Northeast Georgia respectfully overtures the 226th General Assembly (2024) to send to the presbyteries the following proposed amendment for their affirmative or negative votes.

Shall the fourth paragraph of G-3.0106 in the Form of Government be amended as follows?

#### "G-3.0106 Administration of Mission ...

... "All councils shall adopt and implement the following policies: a sexual misconduct policy, a child[,] youth[,] and vulnerable adult protection policy, and an antiracism policy

#### RATIONALE

This amendment builds upon the important work carried out by previous assemblies to provide for institutional protections for at-risk populations within our congregations and councils. Specifically, this amendment would create a constitutional mandate for all councils of the church to include vulnerable adults in our protection policies. The amended language fosters a deeper sense of accountability. By explicitly mentioning "vulnerable adults," we acknowledge our responsibility to protect those who may be at risk due to various factors. This enhancement to the policy framework demonstrates our dedication to a comprehensive approach in upholding the highest standards of ethical conduct. Inclusion is a key value of our faith community. By extending the protection of policies to vulnerable adults, we reaffirm our commitment to inclusivity, compassion, and justice. This addition reflects our core values and emphasizes our mission to create a community that embraces and protects every member.

#### **RECOMMONDATION:**

The Bills and Overtures Committee presents the above two overtures to be sent on to the 226th General Assembly in 2024, and enthusiastically recommends their approval. We thank you for your consideration.



# **Congregational Connections Committee**

Betty Jean Jordan, Chair

The Congregational Connections Committee met on June 20, 2023 and on August 23, 2023, both times via Zoom. They took the following actions and are making the following recommendations to presbytery:

For Information:

- The Hope and Healing mental health training went well. Participants are to be contacted to determine their preference on the next steps to continue our presbytery's mental health training. Future training will be made available to everyone in Northeast Georgia Presbytery, not just the participants in the initial Hope and Healing training.
- 2. The Presbyterian Mission Agency has produced two videos describing the Matthew 25 initiative. One is 6 minutes long, and the other is 30 seconds long. Both have been made available to public broadcasting stations across the country to be broadcast between regular programming. These are also good resources to share with congregations in Northeast Georgia Presbytery.

- 3. Trinity Presbytery had sent a challenge letter to Northeast Georgia Presbytery requesting that it establish a scholarship fund to encourage attendance at the annual conference of the Association of Smaller Congregations (ASC). Potential funding for the ASC conference is already available through two types of grants that Northeast Georgia Presbytery offers: the Assistance Fund and the Connectional Events Fund. Therefore, the Congregational Connections Committee took no action on establishing a separate budget line item for an ASC conference scholarship fund.
- 4. The Congregational Connections Committee will provide information in the presbytery newsletter and at the October 24, 2023 presbytery meeting about the Hunger Action Congregations program that the Presbyterian Mission Agency coordinates. The Hunger Action Congregations program is also an excellent connection to the Matthew 25 initiative, which has Eradicating Systemic Poverty as one of its focuses.
- 5. A Matthew 25 Summit will be held January 16-18, 2024 in Atlanta. The Congregational Connections Committee will share information about this summit as it becomes available with churches in Northeast Georgia Presbytery.

#### Actions:

- Athens Korean Presbyterian Church had applied to the Presbyterian Mental Health Grant Program. They needed \$2,000 in matching funds if they received the grant. The committee voted to make available \$2,000 from its approved Matthew 25 budget to Athens Korean Presbyterian Church for this purpose. This left \$500 in the Congregational Connections Committee Matthew 25 budget should another application be made this year under the "Policy for Stipends for Persons of Color from Northeast Georgia Presbytery Attending Seminary." Athens Korean Presbyterian Church subsequently did receive the grant, and \$2,000 from the Congregational Connections Committee Matthew 25 budget was disbursed to them.
- 2. The committee approved a 2024 budget request to presbytery. The requested budget includes two line items, totaling \$3,500:
  - \$3,000 for Matthew 25 (for stipends for people of color from Northeast Georgia Presbytery attending seminary and other potential Matthew 25 ministry)
  - \$500 for Mental Health Training (for follow up on the 2023 Hope and Healing Conference).

Recommendations:

 The Congregational Connections Committee does not have any recommendations to Northeast Georgia Presbytery at this time.

The committee met, via Zoom, so far this year on Jan. 18, Feb. 15, Mar. 15, May 19, Jun. 21, Jul. 19, Aug. 15, and Sep. 20. Our next meeting is scheduled for Oct. 18.

Current activities and initiatives of the committee

- Ordination Anniversary Notes
   The committee mails out a note of recognition and appreciation to each pastor on presbytery rolls
   during the anniversary month of the pastor's ordination.
- Clergy Cohorts Program The committee subsidizes this wonderful program, which affords our clergy a safe space for fellowship with colleagues and an excellent opportunity for ongoing education; this program accounts for 80% of our annual budget; 2023 is the final year in the three-year terms of two Cohorts. The committee is currently fielding requests to join or continue in Cohorts for the upcoming term.
- Clergy Spotlight Program Serves as a platform for ministers to share personal anecdotes. We encourage pastors to avail themselves of this platform. It has been lightly used so far this year.
- 4. Pictorial Directory This incipient program will provide a password-protected platform (like the NEGA directory) for ministers to post a photo and few basic bio facts. Mike Williams and Judy Grieve have been collecting photos for the directory.
- 5. At the recommendation of Tom Buchanan, the committee has assumed the role of liaison with Honorably Retired ministers. Roughly half of the pastors on our rolls are Honorably Retired. The committee will be hosting gatherings, probably lunches, at rotating geographic locations within the presbytery. An initial fellowship luncheon was held in Augusta on Aug. 22.
- 6. The Clergy Care Committee will co-host, with the Board of Pensions, an all-NEGA pastors' luncheon at Covenant Presbyterian in Athens on Nov. 17.

#### **Presbyterian Campus Ministry** Report to Presbytery, October 2023

**Back to Growth:** PCM is happy to report our first year since the pandemic of student participation growth. There are lots of folks to be thanked for helping make the PSC an hospitable and welcoming environment, but certainly among them are the weekly dinner volunteers from Covenant Athens, First Pres. Athens, Oconee Pres. Presbyterian Village of Athens, and Friendship Presbyterian, and of course, Mike and Pat Waldrip from First Presbyterian, who manage our kitchen and meal prep most weeks. We feed approximately 40 students at weekly meals, and another 150 or so over the course of the year through the PSC Food Pantry. Worship attendance is up as well, with around 30 students participating weekly.

**Branching Out:** PCM Staff has been out on campus and in the community, hosting a panel discussion on *The Christian Case for Inclusion* in the UGA Chapel on 10/12, and leading a workshop on becoming and inclusive congregation at the Social Justice Symposium on 10/14.

**Homecoming Dinner:** As members of the Northeast Georgia Presbytery, you are all cordially invited to attend PCM's annual homecoming dinner. It will be held in our dining hall at 7pm Friday Nov. 3, and in addition to a catered dinner, will feature a state of the ministry address and student testimonials. **Fall Fundraising Campaign:** The Fall Annual Fund campaign is officially underway. This is an especially important year for fundraising, as some of the grants we have relied on for the past number of years are reaching their end. In all cases, these grants were intended as seed grants, given with the hope of achieving financial sustainability. While ministry, budget and staff have all grown over the last five years (for each of which we are thankful to our supporters), with these grants ending, PCM still needs to grow its budget by \$50K continue providing ministry as robustly and efficiently as has led to its growth.
